What Do Early Childhood Educators Need to Know About the Marketplace? It's important to be healthy so you can take good care of yourself and the children who are counting on you. COVID-19 has shown the importance of health coverage and the new law has made **coverage more affordable and accessible than ever through** the Health Insurance Marketplace<sup>®</sup>.

If you choose to buy a health plan through the Marketplace, you may qualify for help paying for health coverage, **even if you weren't eligible for help in the past**.

## #getcovered



- When you submit your Marketplace application, you and your family may be able to save on Marketplace premiums, or qualify for Medicaid or the Children's Health Insurance Program (CHIP), based on your income.
- Preventive services, like shots and screenings, can help prevent illness and other health problems, or find issues at an early stage, when treatment is likely to work best. All Marketplace health plans and many other plans must cover certain preventive services, without charging you a copayment or coinsurance, if your doctor or other provider is in your plan's network.

 Open Enrollment runs from November 1, 2022 – January 15, 2023. Enroll by December 15, 2022, for coverage starting on January 1, 2023. Get a checklist to prepare for enrollment at HealthCare.gov/ downloads/apply-for-or-renew-coverage.pdf. Then enroll in a plan at HealthCare.gov/get-coverage.

- Visit HealthCare.gov/coverage-outside-openenrollment/special-enrollment-period to find out if you qualify for a Special Enrollment Period and enroll in coverage now.
