Ready Region Southeastern Family Council

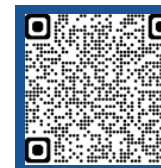
Ready Region Southeastern's Family Council is designed for parents, caregivers, and guardians of children from birth to age five.

Head Start Preschool

Early Head Start:

Must be an infant or toddler younger than 3 years old.

Early Head Start offered in select Western Tidewater locations.

Head Start:

Must be 3 - 4 years old by September 30th (a child who turns 3 after this date is eligible after their 3rd birthday).

Children are eligible for no-cost Early Head Start or Head Start services if one or more factors are met:

- Family income meets program guidelines (under 100% of the federal poverty level)
- Family is experiencing homelessness
- Child is in foster care
- Family is receiving or is eligible for public assistance (SSI, TANF or SNAP)
- Selection criteria to identify children with disabilities
- Other criteria established at the local level

Virginia Preschool Initiative (VPI)

Must be age 4 by September 30th. Some programs serve children age 3.



Children are eligible for no-cost VPI slots at a Public School Program if one or more factors are met:

- Family income meets program guidelines (at or below 200% of the federal poverty level)
- Family is experiencing homelessness
- Parent/Guardian did not complete high school
- Child is eligible for special education services and has a documented disability or delay
- Child is eligible based on local criteria unique to each individual school division
- Eligibility does not guarantee placement; families with the highest need are placed first



Child Care Centers and Family Day Homes

Ages Birth to 5.

All children are eligible for fee-based services based on availability.

- Child Care Centers and Family Day Homes vary in price and some may even offer before and/or after school care.
- Parents could be eligible to receive assistance with the cost of childcare through the Virginia Child Care Subsidy Program.

Mixed Delivery

Full Day, Year-round Care

Ages Birth to 5. Placement based on age by September 30th.



Children are eligible for low or no-cost Mixed Delivery slots at a Child Care Center if one or more factors are met:

- Family income meets program guidelines (at or below 200% of the federal poverty level)
- Family is experiencing homelessness
- Child's Parent(s) or Guardian(s) did not complete high school
- Child has identified disability or needs special education
- Child is eligible based on regional criteria unique to Ready Region Southeastern
- All adults in the home must be participating in one or more of the following activities: *working, job search, and/or education/training, or they are unable to provide care themselves*
